

Writ Petitions under Article 226 of the Constitution of India praying that in these circumstances stated therein and in the respective affidavits filed therewith the High Court will be pleased to issue a writ of mandamus to direct the respondents herein to take effective and emergent steps to disburse the retirement benefits to the workers of the transport corporation, Government of Tamil Nadu (IN WP (MD).10126/2017)

Order: This petition coming on for orders upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of THE VACATION OFFICER MADURAI BENCH OF

MADRAS HIGH COURT for the petitioner and of MR.N.VIJAYANARAYANAN, Advocate General for the Government and of MR.AJAY KHOSE Advocate for the 5th respondent the court made the following order:-

## (ORDER OF THE COURT WAS MADE BY S.MANIKUMAR, J.)

On this day, when the matter came up for further hearing, on the basis of G.O. Ms. No.471 Transport (T.1) Department dated 18.11.2017, Mr.N.Vijaynarayan, learned Advocate General, submitted that, a sum of Rs.462.2158 Crores, has been sanctioned as ways and means advance i.e. a sum of Rs.267.5358 Crores as ways and means advance to all State Transport Corporation Undertakings, towards settlement statutory dues to the retired employees and a further sum of Rs.194.68 Crores as ways and means, to all State Transport Corporation Undertakings towards Motor Vehicle Accident compensation amount awarded by the Courts/Tribunals to the victims, as the second and final settlement as detailed in the above Government Order.

- 2. Learned Advocate General further submitted that insofar as Motor Accident victim cases are concerned, final installement, as assured to this court has been sanctioned. A sum of Rs.462.2158 Crores sanctioned in G.O. Ms. No.471 Transport (T.1) Department dated 18.11.2017, would be disbursed within a week from today. Submission of the learned Advocate General is placed on record. G.O. Ms. No.471 Transport (T.1) Department dated 18.11.2017, shall form part of this order.
- 3. Learned Advocate General has further submitted that the Government have directed the Under Secretary to Government, Transport Department, to present necessary bills with reference to paragraph 6 of the above Government Order to Pay and Accounts Office, Chennai 9, and draw an account payee cheque in favour of the Public Deposit Account No.6184513279 of the Tamil Nadu Transport Development Finance Corporation Limited and disburse the same to the Tamil Nadu Transport Development Finance Corporation Limited.
  - 4. Paragraph No.14 of the Government order, reads thus:
    "14. The Managing Directors of all State
    Transport Undertakings are directed to settle the
    above amount as per the seniority and send the
    utilisation certificate to Government. The Managing
    Director/Financial Advisor & Chief Accounts Officer of
    the concerned State Transport Undertakings are
    strictly instructed that the fund allotted should only
    be utilised for settling MCOP cases and statutory dues
    and should not be used for any other purposes."
- 5. On instructions, learned Advocate General, further submitted that on receipt of the amount from the Government, the Managing Directors of all State Transport Corporation Undertakings, would deposit the compensation amount to the respective Courts/Tribunals dealing with motor accident claim cases, which in

turn, would deposit the compensation awarded by the Tribunals, to the account of the claimants, by RTGS or such other method.

- 6. Placing on record the submissions of the learned Advocate General and the gesture shown by the Government of Tamil Nadu in disbursing compensation to the accident victims/differently abled/legal representatives of the deceased, as the case may be, on the deposit of compensation amount by the Managing Directors of all the State Transport Corporation undertakings in each district, we are of the view that the courts/tribunals dealing with motor accident cases, would transfer/disburse the compensation amount finally determined, by Tribunals/High Court, a list stated to be with the Managing Directors of each Division, to the account of accident victims/differently abled/legal representatives of the deceased, as the case may be, within a period of one week from the date of deposit.
- 7. Registry is directed to send a copy of this order to all the courts/tribunals dealing with the motor accident claims cases.
