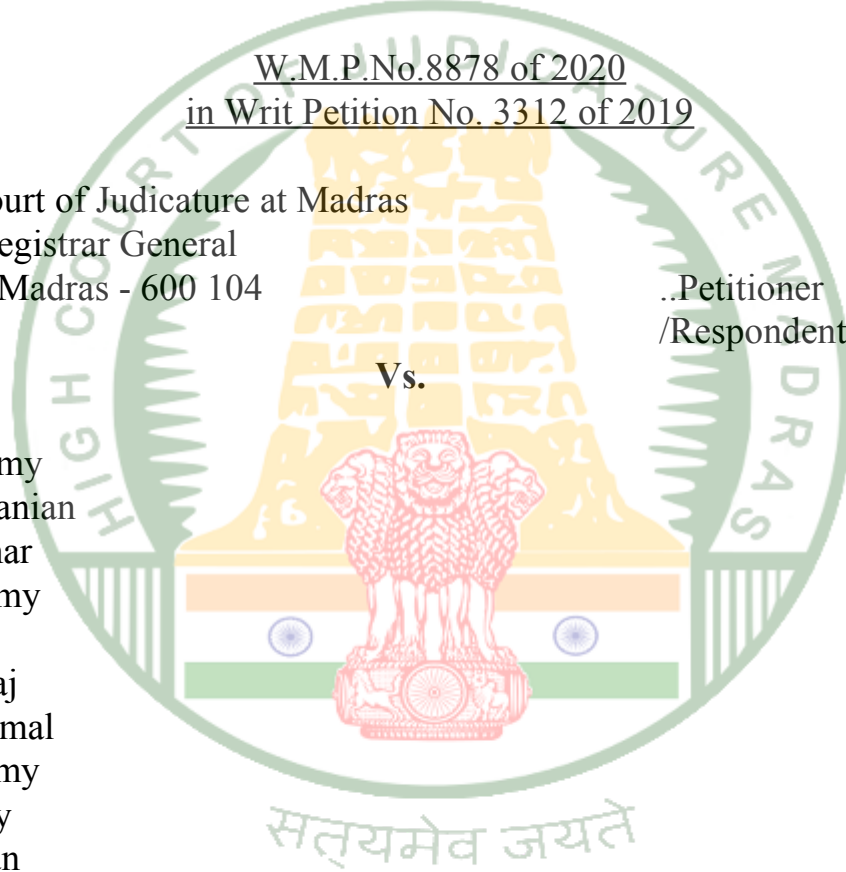

ORDER
(Order of the Court was made by R.SUBBIAH, J.)

This matter is listed today under the caption "for Clarification in W.P.3312 of 2019."

2. We have heard the matter through Video Conferencing. After taking note of the submissions of Mr.V.Ayyadurai, learned Senior Counsel appearing for the Petitioner/R1, this court is inclined to pass the following order:-

The issue involved in W.P.No.3312 of 2019 is only with regard to promotion to the post of Junior Bailiff from the cadre of Office Assistant and Record Clerk. This court has dealt with the aspect of qualification for promotion to the post of Junior Bailiff from the cadre of Office Assistant and Record Clerk in the said order. While passing such order, incidentally we made some observations about the qualification for appointment to various posts covered under Special Rules for Tamil Nadu Basic Service. Therefore, we clarify that the said observation in the order dated 05.11.2019 will not stand in the way of recruitment process to the posts covered under Special Rules for Tamil Nadu Basic Service.

3. The order dated 05.11.2019 passed in W.P.No.3312 of 2019 is thus clarified. W.M.P.No.8878 of 2020 is ordered accordingly.

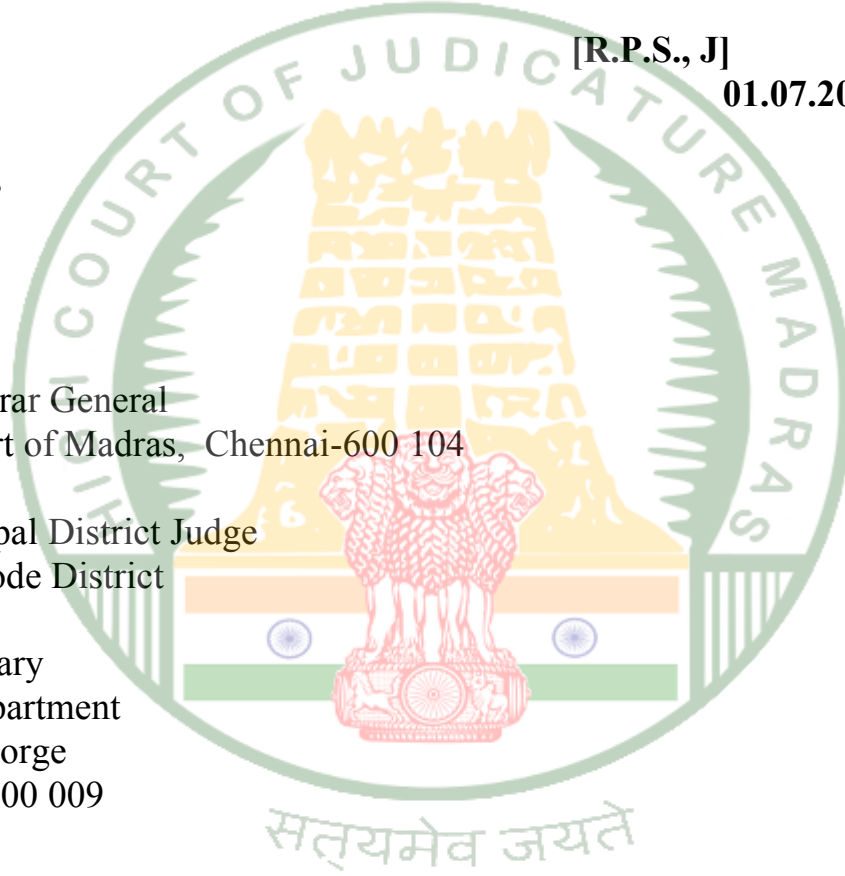
