**ORDER:** This petition coming up for orders on this day, upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of Mr.S.ELUMALAI, Advocate for the petitioner, the Court made the following order:-

The Government shall issue a circular to the Government officials and also request the Government Pleaders to ensure that wherever the civil cases are pending, Government Pleaders are representing the Government, otherwise OSR, Roads, Parks, water http://www.bodsiness.etc., will be grabbed either by the innocent citizens or by

the land grabbers. If no representation is made and if the officials are not going to engage any counsel, they can be taken to task for the loss of property.

2. Whenever the land pertaining to poramboke, OSR etc., mentioned supra, are tried in civil Suit, the respective Court shall ask the plaintiff to make the Government as a party to the proceeding to avoid multiplicity of proceedings.
