The aforesaid nominated Judicial Officers shall instruct their supporting staff (including OAs, Drivers and P.S.Os.) that food and refreshments shall be arranged by them on their own and the Judicial Academy will provide food and refreshments only to the participating Judicial Officers.

The aforesaid nominated officers are required to handover charge of their respective posts to any one of the nearest Civil Judge, as the case may be, **if required**.

The relieving Officers are required to hold full additional charge of the additional posts during the absence of the said nominated Officers.
