Accommodation for the participating outstation Judicial Officers will be provided, if required, and those who require accommodation, should confirm the same to the Regional Centre of Tamil Nadu State Judicial Academy, Coimbatore, **on or before 12.09.2018 by email (tnsja.rc.cbe@gmail.com).** Accommodation will be provided only to those who confirm the requirement to the Regional Centre of Tamil Nadu State Judicial Academy, Coimbatore, within the stipulated time.

The aforesaid nominated Judicial Officers shall instruct their supporting staff (including OAs, Drivers and P.S.Os.) that food and refreshments shall be arranged by them on their own and the Judicial Academy will provide food and refreshments only to the participating Judicial Officers.

The aforesaid nominated Judicial Officers are required to hand over charge of their respective posts, to any of the nearest District Judge, **if required,** before proceeding to attend the aforesaid Two-days Refresher Training Course.

The Officers who relieve the aforesaid nominated Judicial Officers are required to hold full additional charge of the additional post, till the nominated Judicial Officers take charge of their respective posts, after completion of the two-day course.

The aforesaid nominated Judicial Officers from outstations are permitted to claim T.A./D.A. in this regard, as per rules in force.

The absence of the Officers attending the said two day Refresher Training Course from the Headquarters / Office in this regard, is treated as on "Other Duty".

The aforesaid nominated Officers are informed that any request for exemption from participating in the said Training Course, will not be entertained.
