The aforesaid nominated Judicial Officers shall instruct their supporting staff (including OAs, Drivers and P.S.Os.) that food and refreshments shall be arranged by them on their own.

The aforesaid nominated Judicial Officers are required to hand over charge of their respective posts, to any of the nearest District Judge, **if required**, before proceeding to attend the aforesaid Two-days Programme.

The Officers who relieve the aforesaid nominated Judicial Officers are required to hold full additional charge of the additional posts, till the nominated Judicial Officers take charge of their respective posts, after completion of the two-day programme.

The aforesaid nominated Judicial Officers from outstations are permitted to claim T.A./D.A. in this regard, as per rules in force.

The absence of the Officers attending the said two days Programme from the Headquarters / Office in this regard, is treated as on "Other Duty".

The aforesaid nominated Officers are informed that any request for exemption from participating in the said Two days Programme Course, will not be entertained.
