- 3) The officers are not permitted to bring their family members, relatives, friends, court staff members, or any other person, to the place of training. Accommodation, food and other arrangements are made only to the officers nominated.
- 4) The officers will be accommodated in rooms and dormitories; they are required to get adjusted. They will, in no circumstance, be permitted to extend their stay, after the training closes.

- 5) The officers must take adequate care of their belongings, valuables, cash, etc.
- 6) The officers shall secure reservation and confirmation of seat/berth for their return journey from Coimbatore.
- 7) The officers should not possess/consume alcoholic drinks/tobacco products in MTR, which is strictly a NO SMOKING ZONE.
- 8) The officers must stay indoors during night hours after dinner and they should not come out of the rooms/dormitories, without the permission of Academy/Forest Department officials, as the wild animals stray in the open space/forest area during night hours.
- 9) As there is likelihood of severe cold in Udhagamandalam, during the period of visit, the officers are advised to bring with them, apparels, shoes, socks, gloves, etc. meant for withstanding cold weather.
- 10) The officers shall bring the medicines, as may be required for them.
- 11) The officers should follow, without fail, any other instructions as may be given by the Academy/Forest Department officials, from time to time.
