- 3) The officers are not permitted to bring their family members, relatives, friends, court staff members, or any other person, to the place of training. Accommodation, food and other arrangements are made only to the officers nominated.
- 4) The officers will be accommodated in rooms and dormitories; they are required to get adjusted. They will, in no circumstance, be permitted to extend their stay, after the training closes.

- 5) The officers must take adequate care of their belongings, valuables, cash, etc.
