

OFFICIAL MEMORANDUM

Sub: Courts and Judges – Tamil Nadu State Judicial Academy (TNSJA) – Judgment Evaluation and Enhancement of Judgement-writing skills – Phase-II for Civil Judges of 2015 Batch – Direction to organise through video-conference/online and other modes of telecommunications network – proposed to be held during the months of May and June 2020 – Preliminary Meeting on 18.06.2020 – Instructions to be issued to the Civil Judges of 2015 Batch – Requested by the Director, Tamil Nadu State Judicial Academy, Chennai - Considered – Instructions issued.

The Director, Tamil Nadu State Judicial Academy, Chennai, in the letter under reference cited above, has stated that as per the approval of the Hon'ble Governing Body of TNSJA, the training programmes on Judgment Evaluation and Enhancement of Judgement-writing Skills-Phase-II for Civil Judges of 2015 Batch is proposed to be held through video-conference/online and other modes of telecommunication network (Google Meet, Jitsi, CISCO WebEx, Skype etc.,) during the months of May and June, 2020.

Login Instructions Steps to Install Google Chrome Browser in Ubuntu

<u>Step 1:</u> Click on Ubuntu Software icon which is found on the taskbar on the left side of the screen.

- Step 2: Once you click on that icon in the screen that appears,
 - i) You have to type "Google Chrome" in the search box.
 - ii) Then find the Google Chrome for Linux app.
 - iii) Click on Install.
- <u>Step 3:</u> Once click on install, root password will be asked.

 Root password: Enter the respective ROOT password.
- Step 4: After entering root password select authenticate.
- Step 5: After giving authentication the installation will be done automatically.
- <u>Step 6:</u> After installation is finished, you have to verify from the main search box/dash window.
 - -> Type Google Chrome in search box ->will show the window.

You can launch or open Google Chrome form the dash window/search box.

<u>Using Cisco Webex for attending Training Programmes using Ubuntu</u> <u>Laptop.</u>

- 1. You will get the invitation link via e-mail. Check your e-mail.
- 2. Click on the "Join Meeting" link and it will take you to the Webex website. Be sure that you are connected to the internet.
- 3. Click on the "Join Meeting" tab shown in the next webpage. You will join the meeting and will be able to participate.
- 4. After joining the meeting; Please keep your microphone muted so that there will be no audio disturbance during the speech of the Resource person. If you want to ask any questions or to interact, click on "Raise your hand" tab and the speaker or the coordinator will ask you to speak. Now unmute the microphone and you can speak and interact with the speaker.

Using Cisco Webex in Android mobiles:

- 1. Download and install Cisco Webex App from Playstore.
- 2. You can join the meeting by clicking the Join Meeting link received by you in Whatsapp message or e-mail.
- 3. On the next page, again click, 'Join Meeting' and you will be admitted in the meeting.

Protocols to be followed:

- 1. Kindly ensure that you have a good net connectivity.
- 2. Choose a bright and neat place with good and undistracting background.
- 3. Sit in a place where there is sufficient light on your face.
- 4. You are requested to join the meeting 15 minutes before the appointed time.
- 5. The officers are requested to attend the programmes in a formal official dress.
- 6. Ensure silence at and near the place where from you join the meeting.
- 7. Do not "switch on" or "unmute" the microphone unnecessarily.
- 8. You have to speak only when the host gives you the permission.
