The Director (FAC), Tamil Nadu State Judicial Academy, Chennai, in the letter under reference cited above, has stated that the Hon'ble Dr.Justice D.Y.Chandrachud, Judge, Chairman, Hon'ble eCommittee, Supreme Court of India, has addressed a letter to the Hon'ble Chief Justice, High Court of Madras, on 15.01.2021 with copy marked to the Chairperson, Computer Committee, High Court of Madras, proposing a training programme for Advocate Master Trainers in every State by availing the infrastructural facilities of respective State Judicial Academies and that the training is to be imparted by the Core Master Trainers trained at National Level by the Supreme Court of India.

He has further stated that, as directed by the Hon'ble Governing Body of TNSJA, the online TOT Awareness Programme for Advocate Master Trainers in Regional Language through CISCO WebEx is proposed to be held on 13<sup>th</sup> and 14<sup>th</sup> March, 2021, between 10.00 a.m. and 01.00 p.m., for 308 Advocate Master Trainers in six groups by utilizing the services

of the 24 Master Trainers of Madras High Court at TNSJA Headquarters Chennai, and Regional Centres at Madurai and Coimbatore as detailed below:-


