ICT and Computerisation Sensitization and Awareness Programme (ICT-1) for Judicial Officers

PROGRAMME REPORT

As per the Academic Annual Calendar 2021-2022, a "ICT and Computerisation Sensitization and Awareness Programme (ICT-1) for Judicial Officers" was conducted through CISCO WEBEX meet on 08.08.2021 in the Tamil Nadu State Judicial Academy, Regional Centre, Madurai for the Districts; Ariyalur, Dindigul, Kanniyakumari, Madurai, Perambalur, Pudukottai, Ramanathapuram, Sivagangai, Theni, Thoothukudi, Tiruchirapalli, Tirunelveli and Virudhunagar.

Hon'ble High Court has nominated three Judicial Officers as Resource persons, Mr. A.R.V. Ravi, VI Additional District Judge, Madurai, Mr. G. Sudhagar, Chief Judicial Magistrate, Sivagangai and Mr. A. B. Naseer Ali, Sub Judge, Mudhukulathur.

As per Schedule, the programme commenced at 10.00 a.m. with Welcome Address by Mr. S. Muthu Maharajan, Deputy Director, TNSJA Regional Centre, Madurai. The first Session started with all the three learned Resource persons Mr. A.R.V. Ravi, Mr. G. Sudhagar, and Mr. A.B. Naseer Ali, dealing with the topics, "1. GIMS, 2. Official Communications and 3. KAVACH Application" till 11.30 am. The Resource Persons brilliantly explained as to how the GIMS and KAVACH Applications can be installed; how it could be used and its purpose and usage to the participating Judicial Officers. It is also said that in future all the official communications from the Hon'ble High Court will be shared through the GIMS and Official e-mail to the Judicial Officers of the State Judiciary. The participants took part by interacting and clarified their doubts in the first session.

After a short tea break the session continued on the topic "Transfer of Cases" by Mr. A. B. Naseer Ali and "Lokadalat and Mediation in CIS" by Mr. G. Sudhagar. The resource persons explained in detail about the data entry which has to be made for the Transfer of Cases in three types, i.e. Individual Transfer, Bulk Transfer and Establishment Transfer; and how the data entry has to be made in the Lokadalat and Mediation cases in CIS. The importance of the data entry was clearly explained to the Judicial Officers and they were instructed to monitor the data entry that has been made by their concerned staff. The session was followed by interaction with the participants and completed before Lunch.

The Resource Persons extensively covered the topics given to them with their wide wisdom and experience. The Participants also actively participated by interacting with the Resource Persons. At the end of the programme Mr. S. Santhanakumar, Assistant Director, TNSJA Regional Centre, Madurai, proposed the vote of thanks.
