## <u>PROGRAMME REPORT</u>

ICT - Computer Sensitization and Awareness Programme (ICT-1) for Judicial Officers was held on 8<sup>th</sup> August 2021 through Cisco WebEx and the said programme was conducted by the Tamilnadu State Judicial Academy, Regional Centre, Coimbatore. Thiru. P. Srikumar, IV Additional District Judge, Coimbatore, Thiru. K. Arunachalam, Presiding Officer, Additional Labour Court, Coimbatore and Thiru. S. Santhanakrishnasamy, II Additional Sub Judge, Coimbatore were nominated as resource persons.

The programme commenced with the Welcome Address of Deputy Director, TNSJA Regional Centre, Coimbatore. He narrated the scope and object of the programme. The first session was handled by Thiru. P. Srikumar, IV Additional District Judge, Coimbatore and Thiru. K. Arunachalam, Presiding Officer, Additional Labour Court, Coimbatore. The learned Resource Persons explained about Government Instant Messaging System (GIMS). They further explained that GIMS is a messaging platform for instant communication among government users and it is mandatory for the judicial officers to use this application for official communications. In this regard, the learned Resource Persons invited the attention of the audience to the circular of the Honorable High Court in ROC No.30080-A/2020/e-Court dated 15.02.2021. Further, they explained about installation, login procedure and explained about salient features of the GIMS. Further, they enlightened the audience regarding digilocker portal of the Union Government.

Thereafter, they explained about Kavach application. The Resource Persons also narrated installation procedure of the Kavach application. Further, without installation of Kavach applications, officers cannot login their official e-mail id. Hence, the Resource Persons enlightened the participants regarding Kavach. Then, they explained about official communications and usage of digital signature. The learned Resource Persons also explained the procedure relating to digital signature. The 1<sup>st</sup> session concluded at about 11:20 am.

The second session commenced at about 11:35 am and Thiru. S. Santhanakrishnasamy, II Additional Sub Judge, Coimbatore handled the session in respect of Transfer of Cases in Case Information System (CIS) software. The learned Resource Person enlightened the participants regarding individual case transfer, bulk transfer and establishment transfer. Further, live demonstration also conducted with the help of system officers of the District Court, Coimbatore.
