### **EVENT REPORT**

The experience sharing and review meeting for POCSO Judges, JJB Magistrates, Special Public Prosecutors, Police Officials and Legal-cum-Probation officers of the districts of Chengalpattu, Chennai, Cuddalore, Kancheepuram, Krishnagiri, Nagapattinam, Thanjavur, Tiruvallur, Tiruvannamalai, Tiruvarur, Vellore, Villupuram, Union Territory of Puducherry and Karaikal was held by the Tamilnadu State Judicial Academy, Headquarters, Chennai, on 3<sup>rd</sup> October 2021.

The welcome address was delivered by Mr. D. Lingeswaran, Director, TNSJA. He warmly welcomed the august gathering to share their



experiences and best practices adopted by them for the smooth functioning and working in unison of different stakeholders under the Protection of Children from Sexual Offences Act 2012. He also extended his warm greetings to the resource

persons - Mrs. S. Valarmathi I.A.S., Director, Department of Social Defence, Mr. E. V. Chandru @ E. V. Chandrasekaran, Advocate, High Court of Madras and Mr. G. Kumaresan, Social Policy Specialist, UNICEF. He spoke about the need to be updated on the rapid advancements in the Legal and Judicial field as they tend to get out-dated very fast. He spoke about the need for peer learning which helps in the identification of knowledge gaps, discovery of best practices and easy retention of knowledge.

The introductory address for the session was delivered by Mr. G. Kumaresan, Social Policy Specialist, UNICEF. He threw light on various aspects such as rights of children, participation of children in the



Juvenile Justice System, etc. He also reiterated that, no single stakeholder can make an impact, but being united can have a far reaching positive result. He also spoke about how this experience sharing and review meeting is one of its kind where for the first time 5 stakeholders have come together to share their experiences and hardships if any to work more efficiently and protect the children. His speech revolved around the key shades of multi-sectorial responses, accountability, child rights, child protection, prevention, collective action and response action. He appealed the need for the strategic partnership amongst the stakeholders. He assured the support of UNICEF in all the endeavours to protect child rights by emphasizing 'individual social responsibility' and 'best interest of the child'.

Mrs. S. Valarmathi IAS, Director, Dept. Social Defence, talked about the

need to have an effective and speedy disbursal of victim compensation fund mechanism cutting across all the formalities. She discussed with the participants, understood their concerns and re-assured



that collectively everybody can come together and make the system more potent in disbursing compensation without any procedural anomalies affecting the victims who genuinely rely on such interim compensations. Several questions were put forth by the participants which were answered by the resource person.

After a short tea break, the next session was on sharing of experiences and best practices which was moderated by Mr. D. Lingeswaran, Director, TNSJA and Mr. E. V. Chandru, Advocate, High Court of Madras.

This session was about sharing personal experiences and best practices



that are followed by different stakeholders for effective functioning of their duties.

Firstly, the police officials spoke about their experiences and best practices that are adopted by them as a stakeholder under the POCSO Act and JJ Act. Mrs.

Paripooranam, Inspector of AWPS, Gummidipoondi expressed her concerns in dealing with POCSO Victims. She also spoke about her experiences and various methods adopted by her in dealing with POCSO related cases.



Ms. Kannagi, Inspector of AWPS, Madhavaram expressed her concerns about how they are facing non-cooperation from victims and their parents in numerous cases.

Mr. S. Arumugasamy, Principal

& Superintendent of Police, Police Training College, mooted on the point that documentation plays an important part in the Proper Investigation,

Effective Prosecution and Fair Trial in cases. He shared his experience in a case where medical treatment was denied to a victim under POCSO Act because there was no requisition from the Court. He spoke about the lack of awareness of the POCSO Act in the hospitals.



Secondly, the Special Public Prosecutors shared their experiences and concerns. Mrs. T.G. Kavitha, Special Public Prosecutor, Special Court for

POCSO Act, Chennai, gave a summary about how Effective Prosecution can be conducted by highlighting three key areas wherein vigil has to be maintained by prosecutors i.e.,



foundational facts, commissions of offence, and medical evidence. She also spoke about a recent judgement of Madras High Court which discussed the necessity of paternity test in POCSO cases.



Mrs. P. Kala, Special Public Prosecutor, Special Court for POCSO Act,



Villupuram, gave emphasis about examination of witness and how critical it is in POCSO Cases. She emphasized that, victim should not be harassed in any manner.

Thirdly, the Presiding Officers of POCSO Courts shared their

experiences and concerns. Ms. M. Rajalakshmi, Sessions Judge, Special Court for POCSO Act, Chennai, spoke about how negative social attitudes prevent the child from reporting sexual abuse to their family. She also gave instances of ill treatment of the victim by her family, where the victim would have had more than one partner different from the accused prior of the offence being committed. She shared about her practice of continuous trial and giving conditional bail to the accused, which has resulted in effective and speedy disposal of POCSO cases.



Ms. M. Ezhilarasi, Sessions Judge, Special Court for POCSO Act, Cuddalore, spoke about the practice of using coloured dockets in courts to differentiate each case based on the age of the victim child. She also

spoke about the advantage of continuous trial, fixation of trial



proceeding and framing of charges.

Ms. J. Tamilarasi, Sessions Judge, Special Court for POCSO Act, Nagapattinam, spoke about the practice of using coloured dockets for different types of cases. She discussed giving unique

names and titles to the case after reading the remand and FIR papers. She spoke about making notes in the FIR docket sheet about the medical examination, potency test, S. 164 Statement, arrest of accused, the evidences that are not filed, for quick reference. She emphasised how these practices saves a lot of time for judges. She also threw light about awarding interim compensation where necessary. She highlighted about noting down the dates and deadlines which helps in monitoring the progress of the case. Regarding bail she shared her practice of making the accused sign twice every month in a police station till the

summons is served. She also highlighted that if the charge sheet is submitted in advance it can be reviewd by the judge, thus avoiding the need for issuing memo or retuning the charge sheet. She stated that she always tries to build a rapport with the victim child so that the child feels comfortable to tell the truth. She emphasised that, competence of the witness also depends on the child friendly atmosphere in the Court.

After lunch break, the next session was handled by Mr. E. V. Chandru, Advocate, High Court of Madras. Building upon the premise of 'investigation', defined in Section 2(h) of CrPC and 'judicial proceeding', defined in Section 2(i) of CrPC, he explained the concept and scope of fair trial and investigation. He quoted Jeremy Bentham who said "Witnesses are eyes and ears of the Court". Discussing on Sec. 173 of CrPC, 'Report of police officer on completion of investigation' he emphasized S. 173(8) that, nothing in this Section shall be deemed to preclude further investigation in respect of an offence after a report has been forwarded to the Magistrate and whereupon such investigation, the officer in charge of the police station obtains further evidence, oral or documentary, he shall forward to the Magistrate a further report regarding such evidence. He gave an overview about the offences and punishments mentioned under the POCSO Act, 2012. He emphasized

that Procedure under POCSO Act has more weightage than CrPC in POCSO cases. He explained that while Judges have immunity in discharge of their duties, the police do



not, as under Sections 166, 166A, IPC, they are held accountable for disobedience of law. Similarly, on a conjoint reading of Section 166B, IPC; Section 357C, CrPC and Rule 6 r/w Section 27, POCSO Act, doctor is liable for not conducting medical examination. He also cited a plethora of case laws that are relevant to proper investigation, effective prosecution and fair trial. He cited Vinay Thyagi Vs. Irshad Ali (2013) 5 SCC 762 wherein it was held that, "Magistrate cannot order De novo investigation". He explained about the concept of 'protest' its evolution by citing the landmark decision of Vishnu Kumar Tiwari Vs. State of UP AIR 2019 SC 3482. Further, he cited Madan Gopal Kakkad Vs. Naval Dubey (1992) 3 SCC 204, wherein it was held that, "Rape is not a medical condition but a crime." He also covered the important areas that are underlined under the Identification of Prisoners Act, 1920.

Lastly, an Open House discussion on "The importance of background study of the Victim and Accused under POCSO cases" was opened to the floor for discussion wherein the session was moderated by Mr. D. Lingeswaran, Director, TNSJA and Mr. E. V. Chandru @ E. Chandrasekaran, Advocate, High Court of Madras. The session began with the discussion of Probation of Offenders Act, 1958, delving into mercy jurisprudence (emphasizing upon the concept of residual doubt

(In post-conviction stage), reasonable doubt, mitigating and aggravating circumstances, incriminating and extraneous circumstances, persuasive and determinate sentence) and how nature of crime is relevant to



apply mercy jurisprudence. Mr. E. V. Chandru discussed the case of Ashok Debbarma @ Achak Debbarma Vs State Of Tripura (March 2014) wherein the concept of residual doubt was considered. Lastly he also highlighted about 'probate' and its importance.

Mr. V. Neppolian, Legal cum - Probation Officer, Villupuram, spoke about the main channels of their operation and how cautiously they deal with the children who come to Child Welfare Committee.



Ms. D. Sangeetha, Legal cum - Probation Officer, Thiruvallur, spoke about their concerns working in the field of Child Welfare.

Dr. Rachana Singh, Superintendent of Police (East), Puducherry, spoke

about the importance of video recording in cases where there are issues of language translation. The session ended with the discussion on a line of thought adopted by the South African Constitution Courts in





the case of Teddy Bear Clinic for Abused Children and Another v. Minister of Justice and Constitutional Development and Another CCT 12/13) [2013] ZACC 35.

The programme concluded with Mr. R.A.S. ANANDARAJ, Deputy Director, TNSJA Headquarters, Chennai proposing the vote of thanks by thanking every participant and resource person for attending the programme and making it a grand success.
