Professional Development Programme-I for Civil Judges (Batch-I)

11.06.2022 and 12.06.2022

PROGRAMME REPORT

As per the Academic Annual Calendar 2022-2023, a "Professional Development Programme - I for Civil Judges – Batch I" was held on 11.06.2022 and 12.06.2022 in the Tamil Nadu State Judicial Academy, Regional Centre, Madurai for the Districts of Ariyalur, Dindigul, Kanniyakumari, Madurai, Perambalur, Pudukottai, Ramanathapuram, Sivagangai, Theni, Thoothukudi, Tiruchirapalli, Tirunelveli and Virudhunagar.

On 11.06.2022, the training programme commenced with the inaugration by the **Hon'ble Chief Justice** of Madras High Court/Patron-in-Chief, TNSJA from TNSJA Headquarters, Chennai through Video Conferencing. Hon'ble Mr. Justice T. Raja, Judge, High Court of Madras/President, Board of Governors, TNSJA delivered the vision statement for the training programme.

Thereafter the session commenced and the Resource Person Mr. R. Gandhi, Advocate dealt with the topic Bail. He emphasized the significance of recording of reasons, relevant factors for consideration and importance of imposing conditions while passing orders on Bail Petition. The Resource person also explained the procedures for cancellation of Bail. An activity of writing the

Bail Order was conducted at the end of the forenoon session.

On 11.06.2022, in the afternoon session Mr. A. Muralikrishna Anandan, III Metropolitan Magistrate, George Town explained the Role of Magistrates under Domestic Violence Act. He explained the practical aspects in dealing with the DVC cases through power-point presentation and the participants also actively participated and interacted with the Resource Person. At the end of the session, an activity of writing order in a D. V. Application was conducted.

On 12.06.2022, in the forenoon session, Mr. A. Arumugam, Advocate delivered a lecture on "Execution Proceedings: Attachment and Sale/Court Auction/Sale Certificate". The Resource Person through his rich experience and wisdom dealt with the topic practically and addressed all the practical difficulties expressed by the participants while dealing with Execution Petitions.

On 12.06.2022, in the afternoon session, Dr. V. Chandrasekaran, Labour Law Practitioner dealt with the topic "Role of Judicial Magistrate in dealing with offences under Labour Laws". He stressed the role of the magistrates in dealing with labour offences.

At the end of the programme, Impact Assessment was done by Mr. S. Muthu Maharajan, Deputy Director of TNSJA-RC, Madurai. The program turned out to be very successful and the Participants actively took part in the interaction session with the Resource Persons and have been benefitted from the two-day training programme.
