**Professional Development Programme-I**  
**for Civil Judges (Batch-I)**

**Programme Report**

The two-day Professional Development Programme- I for Civil Judges (Batch-I) commenced at 10.00pm on 18-06-2022. The scope and object of the programme was delivered by Mr. D. Lingeswaran, Director, TNSJA. The Director set the tone for the programme by explaining the significance of recording reasons while granting/cancelling bail. He further explained the role of magistrate under the Domestic Violence Act.

The first session was on the topic 'Bail', handled by Mr. S. Prakash, Senior Civil Judge, City Civil Court, Chennai. He started his lecture with the words of Justice V. R. Krishna Iyer, that the issue of bail is one of liberty, justice, public safety and burden of the public treasury, all of which insist that a developed jurisprudence of bail is integral to a socially sensitized judicial process. He explained the types of bail and the principles of granting of bail by mentioning the case laws. The resource person asked questions to the participants relating to the granting of bail in various cases. He also explained the significance of recording of reasons while granting bail with case laws. He mentioned the imposing of

conditions while granting bail and also explained the granting of bail in bailable offence and non bailable offence. He also explained the power of a magistrate with regard to cancellation of bail..

The participants raised their doubts relating to grant of bail and cancellation of bail and the resource person clarified the doubts of the participants. In order to make the participants understand in depth and have a thorough knowledge of granting bail, an activity to write a bail order was given.

The next session was on the topic "Role of Magistrates under Domestic Violence Act" handled by Mr. A. Muralikrishna Anandan, III Metropolitan Magistrate, George Town, Chennai. He gave an introduction about Domestic Violence Act and explained about who can file a case under Domestic Violence Act. He mentioned the rights of aggrieved person and right of divorced wife. He explained in detail the Residential orders and protections orders. He also explained whether a petition for Amendment is permissible in a DV Proceeding. He mentioned various case laws which states; 'not everyone to be summoned and not every respondent should appear'.

The resource person then clarified the doubts of participants. An activity was given to widen the knowledge of participants in Writing an order in a D.V. application.

The first session on day two began with the impact assessment of the participants by Mr. D. Lingeswaran, Director, TNSJA in order to help the participants rectify their mistakes.

The next session was on the topic "Practical issues in Execution Proceedings" which was taken by Mr. N. Ramanathan Chairman, Sales Tax Appellate Tribunal, Chennai and Mr. A. Thiruvenkata Seenivasan, XII Additional Judge (CBI cases), City Civil Court, Chennai. Both the Judges elaborately explained the practical issues and applicability of executive proceedings with the aid of several case laws relating to the execution of proceedings. The resource persons also clarified the participants doubts.

In the post lunch session, the topic 'Execution Proceedings: Attachment and Sale / Court Auction / Sale Certificate' was elaborately discussed by Mrs. Chitra Sampath, Senior Advocate, High Court of Madras. She explained the orders and rules related to execution of movable property. Further, she explained the procedure for attachment and sale. The resource person also explained various case laws relating to Settlement of Proclamation, Courts Valuation In Sop, Failure Of Jd To Raise Objections As To Extent – Effect. The resource person clarified the participants doubts too.

The next session was on the topic "Wildlife Protection Act – A Critical Analysis" by Mr. Sanjay Kumar Srivastava, Principal, Chief Conservator of Forests (Rtd.). He explained the wildlife protection and related schedules. Further,

he spoke about the Permission for hunting of wild animals in certain cases. He explained in detail the destruction and removal of wildlife from Wildlife Sanctuary and National Park and also explained the Possession & Trade in Captive animals. He also explained the salient features of Wildlife Protection Amendment Bill 2021. The participants interacted with the Resource person and clarified their doubts.
