Training programme for Police Officers Investigating Crimes against Women and Children

Event Report

The Tamil Nadu State Judicial Academy and Department of Social Defence, Government of Tamil Nadu in association with Greater Chennai Police and UNICEF organized a Training Programme for Police Officers Investigating Crimes against Women and Children from 13th to 16th of September 2022 for four batch of officers. The training programme commenced at 09.30 am every day with the invocation "தமிழ்த்தாய் வாழ்த்து".



The programme began with the Welcome Address by Mrs. S. Valarmathi, I.A.S., Director, Department of Social Defence, Secretary, State Child Protection Society, Tamil Nadu. Firstly, she welcomed all the dignitaries and the participants for the programme. In her welcome address she

told the investigating officers that they should try to curb crimes swiftly and specially focus on the crimes against women and children particularly the POCSO cases and case where children and women are involved.

Mr. D. Lingeswaran, Director, Tamil Nadu State Judicial Academy explained the Scope and Object of the programme. He spoke about the stakeholders in the Justice Delivery System and reiterated that amongst all the stakeholders the Judges and the Police Officers play a pivotal role. He also emphasized the need for proper investigation which can aid in rendering justice.





The Inaugural Address was delivered by Mr. Shankar Jiwal, IPS, Commissioner of Police, Greater Chennai Police. He emphasized that the police officers should conduct effective and proper investigation. He shared his experience and some useful methods for proper investigation.

Mr. G. Kumaresan, Social Policy Specialist, UNICEF Office for Tamil Nadu & Kerala, proposed the Vote of thanks. He said that the police officers need to be sensitive and cautious while dealing with children.





A session on the topic "Tracing the Unknown in Cases of Murder for Gain" was handled by Mr. S.R. Jangid, IPS, DGP (Retd.), Chennai. He spoke about the use of scientific aids in investigation and said that the coordination with other state police will help the investigation to move to the next

step quickly. Further, he explained the Locard's Principle of Exchange. He also explained about the offender leaving trace evidence at the scene of crime and that the victim will also retain traces of the offender. He also spoke about the Criminal Procedure (Identification) Act, 2022 which speaks about the type of data that may be collected and persons from whom such data may be collected. He also mentioned that the act provides for the data to be stored in a central database.

Common Technical Sessions on all the four days:



From the second day onwards the welcome address was given by Mr. R.A.S. Anandaraj, Deputy Director, TNSJA Headquarters, Chennai. He welcomed all the participants and resource persons. He spoke about the importance of investigation and how this training will be helpful for the investigating officers.

The session on the topic "Collection, Preservation and Analysis of Digital Evidence" was taken by Mr. N. Karthikeyan, Advocate, High Court of Madras. He explained the usage of faraday bags for preserving digital evidence,



which is antistatic compared to plastic bags. He explained about e-SIM and told the participants that it is very important to put the phone in Airplane mode after seizing the mobile phone and immediately note the model, configuration and also record the chain of custody. The resource person explained the difference between copying, cloning and imaging. He further spoke about various techniques and technologies which is helpful in cyber crimes. The resource person concluded with a little glance on Information Technology Intermediary Guidelines and Digital Media Ethics Code Rule 2021 which is relevent for the investigating officers.



The next session was on the topic "Proper Investigation for Effective Prosecution of Crimes against Women and Children" by Mr. E.V. Chandru @ E. Chandrasekaran Advocate, High Court of Madras. Firstly he spoke on prompt registration of FIR in all cognizable cases. He explained the differnce between documentary evidence, oral evidence and material evidence. He spoke about the various provisions for conducting proper and speedy investigation. He explained various scientific methods which can be adopted for effective investigation.



The next session was on the topic "Identifying and Overcoming Challenges in Investigation of Offences against Property" was handled by Mr. M. Mohamed Riyaz, Advocate, High Court of Madras, on 13th, 14th and 15th day of

September, 2022. He said that minor contradictions doesn't affect the case of prosecution. He said that if there is delay in registration of the FIR, one needs to explain the reason for delay. He also said that the court can only admit the disclosure portion in confession statements. A certificate u/s. 65B of Indian Evidence Act, shall be produced along with final report and it must contain all the required details. The resource person reiterated that there shall not be any delay in sending the statements recorded u/s. 161(3) of Cr.P.C. He explained about the procedures to be followed in freezing of bank accounts of the accused persons during the course of investigation. Seizure can be done in the presence of another inspector. The resource person also emphasized the importance of conducting Test Identification Parades in cases where the accused was previously unknown. He pointed out that in most of the property cases, like robbery and dacoity, women and children were victims.



On 16th day of September, 2022, the session on "Identifying and Overcoming Challenges in Investigation of Offences against Property" was handled by Mr. N. Swaminathan, Advocate, Mannargudi. He pointed out certain instances where proper investigation made by certain police officers made big differences in crime detection and social change. He emphasized the significance of proper collection of evidence and recording of the statements of witnesses

immediately after the occurrence without any unnecessary delay. During investigation, even a small clue may lead to bigger results, therefore one shall not miss the opportunity of collecting all the relevant materials from the crime scene, was the point urged by the speaker. He further elucidated the relevant provisions under the Code of Criminal Procedure and Criminal Rules of Practice for the purpose of prompt and effective investigation. The resource person further urged the participants to bestow their attention

in solving crimes against women and children who were always soft target for hardcore criminals.



"Swift Action in Child Sexual Abuse and Hurt Cases" handled was by Mr. D. Lingeswaran, Director, Tamil Nadu State Judicial Academy. He said that in cases of sexual abuse, the complainant can be a child, parents, neighbours, relatives or even a Doctor. The police officers who receive a complaint which discloses cognizable offences is duty bound to register a First Information Report immediately. Citing

Lalitha Kumari Vs Government of Uttar Pradesh, he urged the investigating officers not to delay the registration of First Information Reports. He also explained the importance of immediately recording the statements of injured persons who are admitted in hospitals. He told the participants in appropriate cases the statements of the critically injured persons shall also be recorded through the Magistrate. He also said that delay in registration of FIR affects the case of the prosecution during trial. He reiterated that in Child Sexual Abuse cases, the child survivor should immediately be taken to hospital for medical examination with a medical memo even before registration of FIR. He also said that during medical examination the child survivor should not be admitted in the hospital unnecessarily, unless continuous treatment is necessary in the opinion of the doctor. There was a question-and- answer session moderated by the Director, TNSJA.



The participants freely asked their doubts which were duly clarified by the Director. The participants gave feedback about the training programme at the end of the programme everyday. Certificates were issued to the participants for their participation.
